AMENDMENT TO THE NAVAJO NATION CUSTODY AGREEMENT

THIS AGREEMENT, effective as of the 28 day of Septemer, 2005, is made by and between THE NAVAJO NATION (the "Nation") of Window Rock, Arizona, and THE NORTHERN TRUST COMPANY (the 'Northern'), an Illinois corporation, of Chicago, Illinois.

WHEREAS, the Nation and Northern previously entered into a custody agreement dated December 27, 1990 (the "Custody Agreement") pursuant to which Northern serves as custodian; and

WHEREAS, the Nation and Northern desire now to amend the Custody Agreement;

NOW, THEREFORE, the Custody Agreement is amended as follows, but all unaffected provisions of the Custody Agreement shall remain in full force and effect.

- 1. Section 16 is hereby amended and restated in its entirety to read as follows:
 - "16. Any action required or permitted to be taken by the Nation hereunder shall be by (i) the written direction of the Controller of the Nation (the "Controller") or the President of the Nation (the "President"), or (ii) the written direction of such other person or persons (including any committee or committees) as shall be designated in writing by the Controller or President to act for the Nation. Northern may rely upon an instrument of designation received from the Controller or President appointing a designee to act for the Nation which it believes in good faith has been signed by the Controller or President and filed with Northern. Northern shall incur no liability to the Nation or the Account for acting on any instruction, direction or other communication on which Northern is authorized to rely pursuant to this agreement.
