2. Description of Modifications:

a. Engineer (herein also referred to as SMA) shall perform or furnish the following Additional Services:

Engineer shall provide professional services during construction for a new well house and site piping for the Baca / Thoreau water system. Additional project management, additional construction administration and additional resident project representative services are required by Engineer to monitor the newly added construction scope awarded to contractor via Change Order.

b. The Scope of Services currently authorized to be performed by Engineer in accordance with the Agreement and previous amendments, is modified as follows:

Engineer shall perform the following additional tasks:

Task 1: Project Management and Design Review Meetings

- a) SMA will provide general project management, invoicing, project funding assistance, reporting, and closeout.
- b) SMA will provide monthly progress updates by email to the NNWMB and the Thoreau Chapter.

Task 2: Additional Construction Administration and Management

a) SMA will provide administration and management services during construction, including review and recommendation of coordination with client and contractor, pre-construction conference, monthly progress meetings, contractors pay applications, field observations by engineer, responses to requests for information, review of submittals, complete field orders and change orders as necessary, preliminary and final walk-throughs, issuing and verification of completion of punch

list items, and project startup, attend 11 month warrantee inspection, and closeout requirements.

Task 3: Additional Resident Project Representative Services for Construction

- a) SMA will provide additional Resident Project Representative Services during construction phase.
- b) SMA will provide full time construction observation during installation of underground facilities, and milestone inspection for above ground facilities.
- c) SMA will make daily site visits, when required, in order to observe the progress and quality of the various aspects of the contractor's work. Based on information obtained during such visits and observations, SMA shall determine in general if such work is proceeding in accordance with contract documents and technical specifications (including documentation of field quality control requirements) and shall keep NNWMB informed of the progress of the work.
- d) SMA will verify the quantities in applications for payment and accompanying support documentation and advise of the amounts that the contractor should be paid. SMA will verify and document contractor submittals are in accordance with the technical specification, material received is per the submittals, material installed, tested and measured per the technical specifications.

Assumptions included in the above Scope of Services:

- 1. Total construction period will not exceed four (4) additional months, five (5) days per week, at eight (8) hours per day, which includes drive time and report preparation time.
- 2. During construction, job site safety shall be the sole responsibility of the Contractor. SMA will not manage or control the Contractor's work with respect to means, methods, techniques, sequences or procedures, and/or safety.
- c. The responsibilities of Owner are modified as follows:

- d. For the Additional Services or the modifications to services set forth above, Owner shall pay Engineer the following additional or modified compensation:

A Lump Sum amount of \$200,000.00 based on the following estimated distribution of compensation, including 6% Navajo Nation sales tax (\$188,679.25 + \$11,320.75 tax):

Task 1: Project Management / Design Reviews \$15,000.00 (including tax)

Task 2: Additional Construction Administration \$15,000.00 (including tax)

Task 3: Additional Resident Project Representative \$170,000.00 (including tax)
