# NAVAJO NATION PRIMARY DRINKING WATER REGULATIONS

---

MINIMUM ENGINEERING DESIGN STANDARDS REQUIRED FOR NEW DOMESTIC WATER SYSTEMS

GENERAL REQUIREMENTS FOR SURFACE WATER TREATMENT PLANT OPERATIONS

WATER SAMPLING, MAXIMIM CONTAMINANT LEVELS(MCLs)

# CONSTRUCTION PERMITS REQUIRED

---

NEW WASTEWATER TREATMENT SYSTEM SYSTEM/TREATMENT PLANT

MODIFICATION TO EXISTING WASTEWATER TREATMENT PLANT

NEW SEPTIC TANK AND DRAINFIELD INSTALLATION

NEW PUBLIC WATER SUPPLY SYSTEM CONSTRUCTION

# CLEAN WATER ACT PERMITS

## U.S. ARMY CORPS OF ENGINEERS

---

404 PERMIT-REGULATES THE DISCHARGE OF DREDGED OR FILL MATERIAL INTO WATERS OF THE UNITED STATES

401 PERMIT IS A LOCAL CONSULTATION WITH NAVAJO EPA WATER QUALITY

INITIAL CONSULTATION WITH THE U.S. ARMY CORPS OF ENGINEERS IS REQUIRED IN EITHER 404 OR 401 PERMITTING

404/401 PERMITTING COVERS CULVERTS, DREDGING, EMBANKMENTS

THE LARGER ARPA PROJECTS MAY NEED 404 OR 401 PERMITTING



# STORMWATER POLLUTION CONTROL PLAN

---

COMMONLY REFERRED TO AS SWWP PLAN

CONSTRUCTION DISTURBANCE OVER 1-ACRE REQUIRES A SWWP PLAN

MUST BE SUBMITTED TO NAVAJO EPA FOR APPROVAL

APPLICANT MUST SUBMIT A NOTICE OF INTENT (NOI)

THE PURPOSE OF THIS IS TO PREVENT STORMWATER FROM LEAVING THE PROJECT SITE DURING CONSTRUCTION ACTIVITIES

# OTHER PERMITS REQUIRED

---

DISCHARGE WASTE, POLLUTANT OR COMBINATION OF POLLUTANTS FROM A POINT SOURCE

DISCHARGE OF SEWERAGE INTO THE WATERS OF THE U.S.

OPERATOR PERMIT FOR WASTEWATER TREATMENT SYSTEM

OPERATOR PERMIT FOR WATER TREATMENT PLANT SYSTEM

# NAVAJO NATION SOLID WASTE REGULATIONS

---

ALL OPEN DUMPING SHALL BE PROHIBITED

NO OPEN BURNING OF SOLID WASTE SHALL BE ALLOWED

SOLID WASTE SHALL BE COLLECTED AND TRANSPORTED IN ACCORDANCE WITH NN SOLID WASTE REGULATIONS

ANY TRANSPORTED SHALL USE VEHICLES WHICH HAVE COVERS OR ENCLOSURES TO PREVENT SOLID WASTE FROM BEING RELEASED

---

PORTLAND CEMENT CONCRETE BATCH PLANTS NEED PERMITS

HOT MIX ASPHALTIC CONCRETE BATCH PLANTS NEED PERMITS

PERMITS NEED TO BE COORINDATED WITH THE NAVAJO ENVIRONMENTAL PROTECTION AGENCY
