- 1. Bidders must be an Authorized Fully Certified Automotive Dealership. All vehicles are to be delivered in a timely manner as the bid evaluation is based on dealership who is most responsive.
- 2. Bid price shall be FOB (Freight on Board) with delivery made to the Navajo Nation Fleet Management Department in Window Rock, Navajo Nation (AZ).
- 3. The manufacturer published warranty shall apply to all vehicles purchased.
- 4. The bid price shall be effective on the date of notice of selection and guaranteed for 90 calendar days.
- 5. NNFRFO and/or Navajo Nation Fleet Management may make on-site visits to either manufacturer or dealership to ensure compliance with specifications are met.
- 6. The Navajo Nation Fleet Management shall receive, at time of vehicle delivery, all pertinent documents necessary for titling and licensing vehicles.
- Submission of all bids are to include: four (4) packets enclosed in one envelope. The outside of the envelope
 must be clearly marked with the following: Respondent's name and contact information, RFB number, SUV
 Purchase.
- 8. Any sealed bid received after the closing date and time will not be accepted and will be returned to the sender. Faxed or emailed bids shall not be accepted. Seal bid must include Navajo Nation Debarment and Suspension Form (Exhibit A) and W-9 Form (Exhibit B).
- 9. NNFRFO shall reserve the right to reject any or all bids.

- 10. Certified Navajo Business must include proof that their business is currently certified by the Navajo Nation Business Regulatory Department.
- 11. Taxes: All performance under this bid is subject to the six percent (6%) Navajo Nation Sales Tax (24 N.N.C. 601 et seq.)
- 12. Nothing in this RFP is intended to or shall have the effect of waiving Navajo Nation sovereignty.
- 13. The Navajo Nation is a sovereign government and all procurement shall comply with Navajo Nation laws, regulations, including the Navajo Nation Business Opportunity Act, Navajo Preference in Employment, and applicable federal laws and regulations.
